**NYSDOH Pregnancy Risk Assessment Monitoring System (PRAMS)** dashboard application has been updated and is now available on the NYS Department of Health website: [https://apps.health.ny.gov/public/tabvis/PHIG\\_Public/prams/](https://apps.health.ny.gov/public/tabvis/PHIG_Public/prams/).

The NYS PRAMS dashboard is an interactive application that presents health statistics and trend graphs for 74 maternal and child health indicators collected from the PRAMS survey. These data are presented for 2004-2020 for three regions: NYS, New York City (NYC), and NYS outside of NYC. Visualizations include annual data tables and trend graphs by demographics (maternal age, race/ethnicity, education, Medicaid status, marital status, and region).

PRAMS is a rich data source for information on maternal experiences and behaviors before, during, and after pregnancy that are not available from other data sources. The dashboard indicators cover: breastfeeding initiation and duration, infant safe sleep practices, hospital experiences around breastfeeding, maternal oral health, nutrition, tobacco and alcohol use, family planning including unintended pregnancy, preconception health, prenatal care education, prenatal care, prenatal health conditions, postpartum care, postpartum depression, stressors, physical abuse, vaccinations (flu/tdap), and health insurance around pregnancy.

In the most recent update, a new tab called ‘Demographic Report’ was added to the dashboard to present the distribution of sociodemographic characteristics in the NYS PRAMS population, by region and year. Additionally, for the ‘Annual Report’ and the ‘Trend Report’, **five new indicators were added:**

1. High blood pressure during pregnancy
2. Depression during pregnancy
3. Lack of insurance three months before pregnancy
4. Lack of insurance for prenatal care during pregnancy
5. Lack of health insurance after delivery

**Two indicators were combined into one:** “Flu shot before pregnancy” and “Flu shot during pregnancy” were combined into “Received a flu shot before or during pregnancy.”

## **NYSDOH Behavioral Risk Factor Surveillance System (BRFSS) Reports**

The Behavioral Risk Factor Surveillance System (BRFSS) is an annual telephone survey of adults developed by the Centers for Disease Control and Prevention conducted in all 50 States, the District of Columbia, and several US Territories. The New York BRFSS is administered by the New York State Department of Health to provide statewide and regional information on behaviors, risk factors, and use of preventive health services related to the leading causes of chronic and infectious diseases, disability, injury, and death. Data from the BRFSS are useful for planning, initiating, and supporting health promotion and disease prevention programs at the state and federal level, and monitoring progress toward achieving health objectives for the state and nation.

**A new BRFSS Survey Report:** [Electronic Cigarette Use, NYS Adults 2020](#) published by the Department found that among New York adults, the highest rate of e-cigarette use is among young adults, ages 18 to 24, which is more than triple the e-cigarette use rate for adults 25 years of age and older.

Key findings of the Department's latest BRFSS report:

- The prevalence of e-cigarette use among adults in New York State in 2020 is 4.1%.
- E-cigarette use is significantly higher among the following groups of adults:
  - 18 to 24 years of age at 10.6%
  - Current cigarette smokers at 10.2%
  - Individuals reporting frequent mental distress at 6.9%
  - Individuals enrolled in Medicaid at 5.9%
  - Individuals identifying as male at 5.7%

**Another new BRFSS survey report “[Prevalence of Diagnosed Prediabetes and Testing for High Blood Sugar, NYS Adults, 2020](#)** provides updated prevalence estimates of diagnosed prediabetes in the state. According to the report:

- An estimated 1.5 million adult New Yorkers (11.0%) have been diagnosed with prediabetes.
- Adults with obesity (19.2%) and overweight (11.0%) are significantly more likely to report being diagnosed with prediabetes compared to adults who have neither overweight nor obesity (5.9%).
- Diagnosed prediabetes is also more common among older adults, Black non-Hispanic adults, adults living with a disability, and adults living in New York City.
- The prevalence of diagnosed prediabetes is higher among adults who were tested for high blood sugar in the past 3 years (18.2%) than among those who were not tested in the past 3 years (4.7%).
- Younger adults and adults without health insurance coverage are less likely to have had blood sugar testing.
- Among adults over 45 years in age, 60.4% report having a test for high blood sugar or diabetes within the past three years, below the PA goal of 71.7%. Among low income (less than \$25,000) adults over 45 years in age, 60.4% report having had a test, below the PA goal of 67.4%.

This report has been approved for public release. Please feel free to use and share this report and its data with your partners and colleagues involved in initiatives to prevent and control diabetes among adults in NYS.

## CDC Radiation and Health

January is National Radon Action Month. Make plans in 2023 to test your home for radon, and if your numbers are high, get it fixed.

Radon is an odorless and invisible radioactive gas naturally released from rocks, soil, and water. Radon can get trapped inside homes and buildings and build up in the air. Over time, breathing in high levels of radon can cause lung cancer.

Radon is the second leading cause of lung cancer in the United States after smoking. According to estimates from the Environmental Protection Agency, radon causes over 21,000 lung cancer deaths each year, and one in 15 homes in the United States have high radon levels.

As part of National Radon Action Month, CDC is hosting its third Radon Awareness Week from January 23–27. This year's theme is "The 5 Ws of Radon: What's Your Radon Story?" Each day of the week will have its own theme, graphic, set of messages, and related story. The five daily themes are:

1. **Who** is affected by radon?
2. **What** are the health effects of radon?
3. **Where** can I be exposed to radon?
4. **When** should I install a radon reduction system?
5. **Why** should I raise awareness about radon?

## **PHCC's Misinformation Alerts and Damar Hamlin**

The spread of misinformation and disinformation on COVID-19 vaccine safety and efficacy continues. On January 2, 2023, football player Damar Hamlin collapsed on the field and suffered a cardiac arrest during an NFL game. Since Hamlin's collapse, there has been widespread misinformation baselessly attributing his injury to his COVID-19 vaccination. ## Policies that Reduce Stigma are Critical to Ending the HIV Epidemic | ASTHO

People living with and perceived to be at greater risk for HIV often face negative attitudes and false beliefs. Stigma and misunderstanding of transmission have led to policies that discriminate against people living with HIV or against people who have been disproportionately impacted by the virus. Furthermore, studies on intersectional stigmatized identities and HIV indicate that people from socially marginalized identities experience worse treatment and care outcomes. Policymakers have been reconsidering several of these policies, and public health is hard at work combatting this stigma through robust prevention and sex education as well as by normalizing HIV testing. ## Public Health Forward: Modernizing the US Public Health System Implementation Guide

Last December, the de Beaumont Foundation joined the Bipartisan Policy Center and eight leading public health organizations to release [Public Health Forward: Modernizing the U.S. Public Health System](#), a five-year roadmap for public health. The report offered detailed recommendations for policymakers and public health leaders, shaped by a bipartisan task force of current and former elected officials as well as leaders in the nonprofit, public health, and health care spaces. Now, a new implementation guide featuring 10 state and local health departments aims to bring those recommendations one step closer to reality: to share real-world experiences, stepwise guidance, useful details, and lessons learned by practitioners across the country who have already put them into practice.

### How to Use the Public Health Workforce Calculator

The Public Health Workforce Calculator is a tool to help local health departments with workforce planning efforts by utilizing information provided about the local health department to estimate the number of full-time equivalents (FTEs) needed to ensure the provision of the Foundational Public Health Services. **The Calculator is intended for use in decentralized public health systems that serve less than 500,000 residents.**

The Calculator has two user options, **basic** and **advanced**. Basic users should use their best judgement to estimate approximately how many FTEs spend time contributing to each [Foundational Capability and Foundational Area](#). Advanced users are health departments who have participated in the Foundational Public Health Services (FPHS) related Capacity and Cost assessing.

**The User Guide should be used alongside the Calculator;** it will help you determine which user option is best based on available data, provides definitions and details on how to enter data, and provides a template for advanced users to complete before inputting data into the Calculator.
