## Center for Environmental Health – Foodborne Disease Outbreak Tabletop Exercise

“Three Steps and a Hop”, is a one-day foodborne illness outbreak investigation tabletop exercise, for Local Health Departments and State Regional and District Offices. One exercise is scheduled in each region. Sign-in will start at 9:30am at each event and the exercise will run from 10:00am-3:30pm. There is no registration fee to participate.

### Who Should Attend

The target audience is individuals who work on foodborne disease investigations. Due to limited seating, we are limiting registration to one communicable disease and one environmental health representative from each county. We encourage attendance of one environmental health staff from state district offices for each partial service county in their jurisdiction. All regional environmental health field coordinators who assist with foodborne outbreaks should attend. A short train-the-trainer session during the day will provide tips and information on how participants can implement the training to colleagues at their own health departments. ## NYSDOH - Behavioral Risk Factor Surveillance System (BRFSS) Reports

The Behavioral Risk Factor Surveillance System (BRFSS) is an annual telephone survey of adults developed by the Centers for Disease Control and Prevention conducted in all 50 States, the District of Columbia, and several US Territories. The New York BRFSS is administered by the New York State Department of Health to provide statewide and regional information on behaviors, risk

factors, and use of preventive health services related to the leading causes of chronic and infectious diseases, disability, injury, and death. Data from the BRFSS are useful for planning, initiating, and supporting health promotion and disease prevention programs at the state and federal level, and monitoring progress toward achieving health objectives for the state and nation.

The New York State Department of Health Alcohol Surveillance and Epidemiology Program is pleased to announce the release of the updated [Behavioral Risk Factor Surveillance System Brief: Binge and Heavy Drinking, New York State Adults, 2022](#) and a new [Information for Action Report: Understanding New Yorkers Opinions on Public Health Policies to Reduce Excessive Alcohol Use](#). The reports are accompanied by a press release from the Department, which is quoted below.

The report [Binge and Heavy Drinking, New York State Adults, 2022](#) provides information on two patterns of excessive alcohol use: binge and heavy drinking. Excessive alcohol use is a common health-related behavior among New York State adults and consumption patterns vary across population groups. Key findings from the report include:

- Nearly 1 in 5 NYS adults (18.4%) reported excessive alcohol use in the form of either binge or heavy drinking, with an estimated 16.6% of adults in New York State reporting binge drinking and 6.1% reporting heavy drinking.
- The prevalence of binge drinking increased significantly from 14.9% in 2021 to 16.6% in 2022.
- The prevalence of binge drinking was higher in males, adults who identify as White, non-Hispanic, adults who were less than 35 years of age, and adults with an annual household income of \$75,000 or more.
- The prevalence of binge drinking among adults who reported current smoking (27.4%) was almost double the prevalence reported among those who did not currently smoke (15.3%), and the prevalence of heavy drinking was more than two times greater among people who smoked (13.6%) as compared to people who did not smoke (5.2%).

The report [Understanding New Yorkers Opinions on Public Health Policies to Reduce Excessive Alcohol Use](#) highlights data from a January 2023 survey of adult residents of New York State on support for five evidence-based policies to reduce excessive alcohol use. Excessive alcohol use contributes to health problems and has an uneven impact on communities that have more places selling or serving alcohol, creating health inequities. To ensure that all New Yorkers have a full and fair opportunity to be as healthy as possible, it's essential that every community benefits from policies curbing excessive alcohol use and preventing associated harm. Often, communities facing economic or racial injustice are the same communities that lack these public health protections.

According to the report, support for alcohol-related policies among New York State adults varied:

- Three-quarters (75%) of New York adults support requiring additional health warnings on alcohol containers and 56% support banning outdoor advertising of alcohol.
- Nearly half of New York adults support increasing the sales tax on alcohol products and just under half (47%) support limiting the days or hours that alcohol is sold.
- Forty-one percent support decreasing the number of stores that sell alcohol products.

An understanding of public opinion is crucial in shaping public health policies. Effective communication, community engagement, and policy promotion are influenced by an understanding of how the public perceives and responds to health-related policies.

The New York State Department of Health's Alcohol Surveillance and Epidemiology Program conducts public health surveillance on excessive alcohol use and its related harms and works in partnership with the New York State Office of Addiction Services and Supports to reduce excessive alcohol use. ## EPIC Exchange – Flooding

Weather-related incidents such as flooding can pose a public health threat. Flooding occurs in every U.S. state and territory and is the most common of all weather-related natural disasters. Floods can happen during heavy rains, when ocean waves come on shore, when snow melts quickly, or when dams break. CDC works to reduce harm and protect lives by helping communities prepare for, respond to, and recover from emergencies.

Floods, big or small, can be devastating for your home and your family. Learn what you can do to stay safe and protect your health from the dangers of flooding.

### Know the Types of Alerts

Before and during a flood, emergency alerts might be broadcast on television, radio, or your cell phone. The level of risk is greatest with flood warnings. Stay informed and understand the different types of alerts:

- **Warning:** Flooding is expected to occur or is already occurring in your area or nearby, and its impact may be serious.
- **Advisory:** Be Aware. Flooding is not expected to be bad enough to issue a warning. However, it may cause significant inconvenience, and can become dangerous.
- **Watch:** Be Prepared. A Flood Watch is issued when conditions are favorable for flooding. It does not mean flooding will occur, but it is possible.\*

### Protect Your Health from Floodwater Hazards

The initial damage caused by a flood is not the only risk. Standing floodwater can also spread infectious diseases, bring chemical hazards, and cause injuries.

Floodwater can pose a drowning risk for everyone—regardless of their ability to swim. Swiftly moving shallow water can be deadly, and even shallow standing water can be dangerous for small children. Always follow warnings about flooded roads. Don't drive in flooded areas—cars or other vehicles won't protect you from floodwaters. They can be swept away or may stall in moving water.

If you must enter floodwater, wear rubber boots, rubber gloves, and goggles. Wash the part of your body that touched floodwater with soap and clean water as soon as possible. If you don't have soap or water, use alcohol-based wipes or sanitizer. Take care of wounds and seek medical attention if necessary. Wash clothes contaminated with flood or sewage water in hot water and detergent.

### Be Safe When Reentering a Flooded Home

When a home has been flooded, it may be contaminated with mold or sewage, which can cause health risks for your family. After you return home, if your home was flooded, practice safe cleaning. Remove and throw out drywall and insulation that was contaminated with floodwater or sewage. Throw out items that cannot be washed and cleaned with a bleach solution, such as mattresses, pillows, carpeting, carpet padding, and stuffed toys. You may want to temporarily store items outside of the home until insurance claims can be filed. Clean walls, hard-surfaced floors, and other household surfaces with soap and water and disinfect with a solution of one cup of bleach to five gallons of water. ## **JAMA Network: Reducing Hospitalizations and Multidrug-Resistant Organisms via Regional Decolonization in Hospitals and Nursing Homes —**

Reducing infections and combating the spread of multidrug-resistant organisms (MDROs) and related infections in healthcare settings may be more effective on a regional scale, as patients often travel to and between multiple facilities in a healthcare system. In this study, decolonization practices included bathing a patient with a soap that kills germs on the skin, chlorhexidine, and putting an antiseptic ointment, nasal iodophor, in their nose. **Morbidity and Mortality Weekly Report (MMWR) — Interim Effectiveness of Updated 2023–2024 (Monovalent XBB.1.5) COVID-19 Vaccines Against COVID-19–Associated Emergency Department and Urgent Care Encounters and Hospitalization Among Immunocompetent Adults Aged ≥18 Years — VISION and IVY Networks, September 2023–January 2024** On September 12, 2023, CDC's Advisory Committee on Immunization Practices recommended updated 2023–2024 COVID-19 vaccination with a monovalent XBB.1.5–derived vaccine for all persons aged ≥6 months to prevent COVID-19, including severe disease. Although 1 updated vaccine dose is recommended for most persons aged ≥5 years, vaccination coverage with updated vaccines has remained low, including among those at highest risk for severe disease, such as adults aged ≥65 years. Thousands of persons in the United States continue to be hospitalized with COVID-19 each week, including approximately 31,000 during January 7–13, 2024, despite endemicity and increased population immunity to SARS-CoV-2. [Notes from the Field: Reemergence of Mycoplasma pneumoniae Infections in Children and Adolescents After the COVID-19 Pandemic](#). Mycoplasma pneumoniae is a common cause of mild

respiratory illness, though severe infection can lead to pneumonia. Resistance to macrolides, the recommended treatment, is widespread in Asia though uncommon in the United States. *M. pneumoniae* infections decreased globally during the COVID-19 pandemic. Data from the National Syndromic Surveillance Program and the New Vaccine Surveillance Network showed an increase in *M. pneumoniae* in the United States beginning in fall 2023, though below pre-pandemic levels.

A [recent Centers for Disease Control and Prevention \(CDC\) Morbidity and Mortality Weekly Report \(MMWR\)](#) found that Long COVID impacts thousands of U.S. Adults. The findings from this study highlight the importance of local planning and programs to meet the health care and support needs of those experiencing Long COVID, as well as additional surveillance for Long COVID at the state, tribal, local, and territorial levels to better understand disparities in Long COVID across the U.S.

Since 2014, the Public Health Workforce Interests and Needs Survey (PH WINS) has become an essential, impactful tool for the profession. This year, the survey [will be expanded](#) to include all local health departments, plus U.S. territories and freely associated states.

The 2024 Public Health Workforce Interests and Needs Survey (PH WINS) is a national survey of the public health workforce that will be conducted in September 2024 and aims to encompass all state health agencies, local health departments, and US territories and freely associated states. A partnership between the de Beaumont Foundation and the Association of State and Territorial Health Officials (ASTHO), PH WINS is made possible through collaborations with all ten Regional Public Health Training Centers, the Centers for Disease Control and Prevention (CDC), Big Cities Health Coalition (BCHC), and the National Association of County and City Health Officials (NACCHO).

PH WINS surveys the entire public health workforce at participating agencies and is the only nationally representative survey to collect this individual-level data. When the survey is fielded, employees will receive it via email, with a three-month completion window, taking approximately 20-25 minutes to answer its questions.
