She has led a diverse array of initiatives in hospital, population health-based and nonprofit membership association settings.

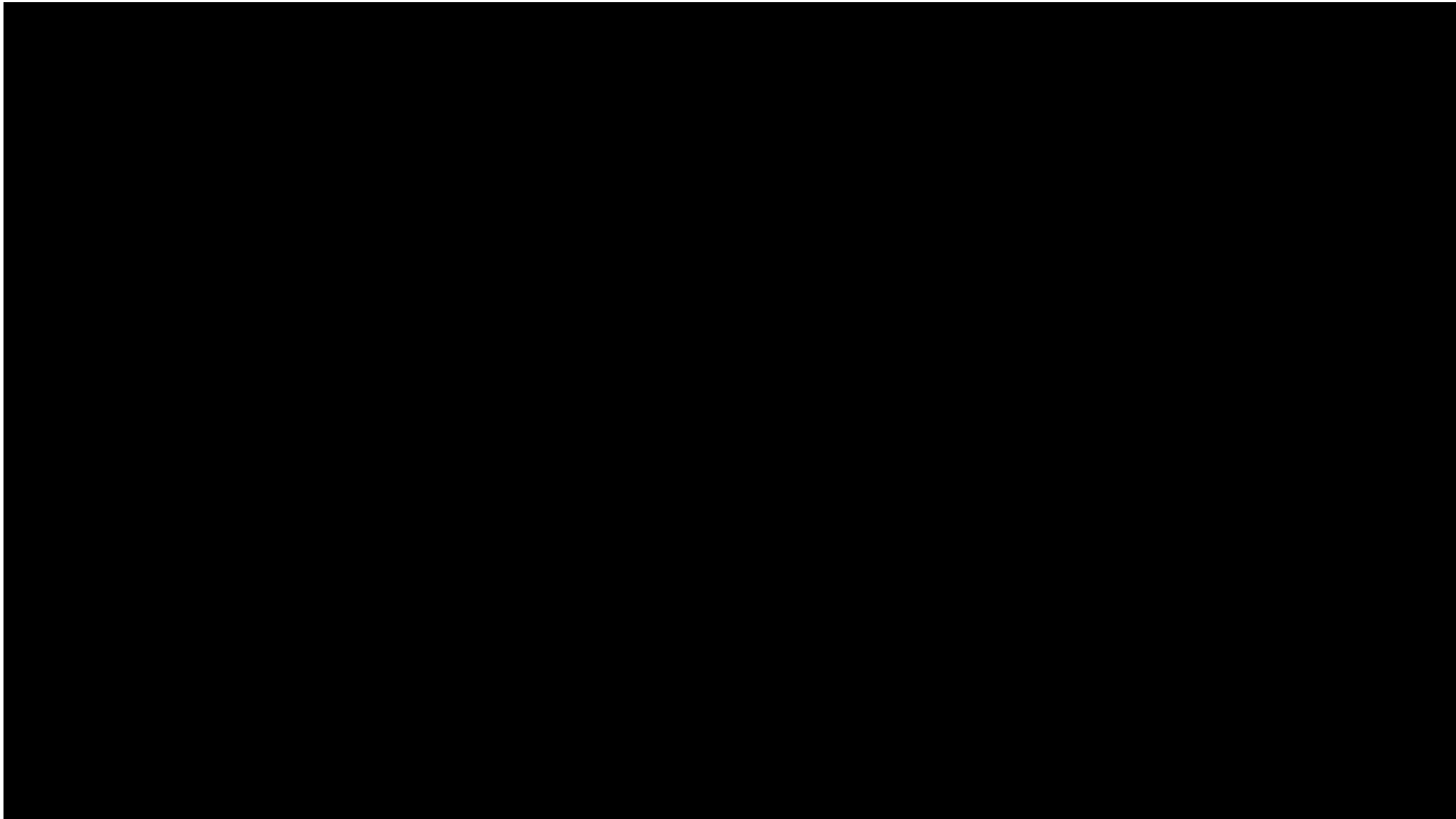
In her role, Sarah is responsible for administration and operational oversight, membership satisfaction, partnership development and utilizing innovative strategies to advance the organizational mission forward.
