ICYMI: June 4, 2024 Disability and Disaster Preparedness

Disasters can have a bigger impact on people with disabilities. By creating a disaster preparedness plan, practicing it regularly, and keeping an emergency supply kit, caregivers can help build disaster resilience for their care recipient.

Know the risks. The first step is to identify risks the person in your care is most likely to face and barriers to taking safety actions. By understanding risks and barriers, caregivers can identify and address gaps that impact emergency preparedness for the person in their care. Consider these questions:

- How does my care recipient best understand and respond to information? How does this change in stressful or unfamiliar situations?
- Do we need assistive technology to meet daily activity needs?
- How do I inform first responders or emergency response personnel about the communication needs of my care recipient?^[1]

Plan for your care recipient's needs. Know what to do if resources become limited or unavailable:

- Keep a list of names and phone numbers of doctors, pharmacists, and family members and others who support you.
- Write down and keep the web address and passwords for any health portals needed for communication with healthcare providers.
- Make sure your care recipient wears medical alert tags or bracelets (full name, contact number for family member/caregiver, and allergies).

Check your emergency kit. In addition to having basic survival supplies such as food and water, a caregiver's emergency kit should provide for their care recipient's individual needs:

- Keep extra sets of batteries if medical or other assistive devices need batteries.
- Have at least a 3-day supply of medicine. If medications need to be kept cold, have a cooler and ice packs available.
- Take pictures of settings on medical devices or equipment in case they need to be reset after a loss of electrical power.

Ways to Get Help

Learn about tools and systems to help you overcome barriers that could cause risk to your care recipient:

- **Emergency prescription laws:** Each state has different laws that authorize pharmacies to refill prescriptions early in the event of a declared emergency. [Learn the laws in your state.](#)
- **If you don't have insurance:** [The Emergency Prescription Assistance Program \(EPAP\)](#) helps people in a federally identified disaster area who do not have health insurance to get the prescription drugs, vaccinations, medical supplies, and equipment they need.
- **Smart911:** Sign up for [Smart911](#) so that you can provide important information to first responders that will help police, fire, and emergency services locate and help you in an emergency.
- **Power restoration:** If your care recipient relies on electricity for medical devices or assistive technology, ask your electricity supplier how to get on a priority restoration list or if they can provide battery backups.

NEW! June 13, 2024 - WHO urges more surveillance, greater One Health focus in responses to H5N1 outbreaks in animals, human cases; USDA reports 12 states with affected dairy herds [Global surveillance of influenza viruses](#) affecting animals needs to scale up in order to rapidly detect any changes in the virus that could pose a greater risk to humans, WHO Director-General Dr. Tedros Adhanom Ghebreyesus said this week. He and other WHO officials stressed that communities could be doing a better job using a [One Health approach](#) to biosecurity efforts to mitigate any potential spillover to humans and possible onward spread of flu viruses, particularly those areas in the US experiencing avian influenza A(H5N1) outbreaks in dairy cattle and other animals. One of the ways to do this is by implementing more widespread testing of people, not only those in contact with livestock; but [several barriers exist to quickly ramping up testing](#) availability in the US. At this time, however, the [risk to public health from H5N1 remains low](#), WHO noted, but urged greater surveillance is needed to prevent being caught off guard like the world was in 2009, when [H1N1 “swine flu” killed between 200,000 and 300,000 people](#) globally.

US situation - According to the US Department of Agriculture (USDA), H5N1 outbreaks have been [detected in 12 US states](#) (Texas, Kansas, Michigan, Idaho, New Mexico, Ohio, North Carolina, South Dakota, Colorado, [Minnesota](#), [Wyoming](#), [Iowa](#)) in at least 93 dairy cattle herds since March 25. A new [USDA report](#) highlights cattle movement, personnel sharing, and contaminated vehicles and other equipment as facilitating spread of the virus to new farms. The report notes that wild birds do not appear to be associated with spreading the virus from herd to herd. [Experts have criticized](#) the USDA and the federal response for poorly tracking the virus, releasing limited information on genomic sequences and where infected herds are located, and generally having a lackluster response.

US state responses to cattle outbreaks - US states are taking various approaches to respond to the outbreaks. Michigan—which accounts for about one-third of the country’s confirmed cases in dairy cattle and 2 of the 3 cases detected in humans—is [taking an aggressive approach](#) in its response efforts. Experts hope other states are looking to Michigan, as well as the

for lessons on how to [scale up biosecurity practices](#). Wisconsin, which has not yet reported an outbreak in dairy cows, this week instituted a [requirement](#), effective June 19, that lactating cows must be [tested for influenza A](#) prior to being moved to fairs or exhibitions.

Detections in other mammals - Notably, the virus is found in [at least 2 dozen types of mammals](#) other than cows. In its latest updates, the USDA Animal and Plant Health Inspection Service (APHIS) reported [3 dozen more H5N1 detections in house mice](#)—all in the same county in New Mexico—as well as [4 more detections in cats](#), including one in Oklahoma, the state’s first detection of H5N1 in any mammal. Further spread of the virus among cows and other mammals presents [additional opportunities for human infections](#), US CDC officials warned today. For more information on when detections are made and the responses, Think Global Health, in partnership with Global.health, launched a [timeline on the US H5N1 outbreak](#), which will be updated weekly.

The [Center for Outbreak Response \(CORI\)](#) provides several [regularly updated resources](#) on the US outbreak, including a health risk assessment and situation update.

Transmission, vaccine research underway - In a study published in [Emerging Infectious Diseases](#), researchers report that a clade 2.3.4.4b H5N1 virus isolated from the human case in Texas caused death among ferrets inoculated with the virus via the eye and was transmissible among the animals. The research underscores the public health threat posed by influenza A viruses. The USDA and the Michigan Department of Agriculture and Rural Development, working with Michigan State University scientists, are [planning to research](#) whether H5N1 is spreading via respiratory routes among dairy cattle. Additionally, [24 companies and USDA researchers](#) are working to develop an avian flu vaccine for cattle, according to Agriculture Secretary Tom Vilsack.

About 7% of US adults have experienced long COVID; NASEM proposes new definition for condition - [About 7% of US adults have experienced post-COVID-19 conditions](#), according to data from a survey sponsored by the Agency for Healthcare Research and Quality (AHRQ). Overall, more women (8.6%) than men (5.1%) reported long COVID symptoms, and the rates were highest among people of middle age. There were also [demographic differences](#), with Hispanic and White adults reporting higher rates of long COVID symptoms than Asian and Black adults. Additionally, adults with certain preexisting conditions were more likely to report ever having long COVID than all adults. The survey results support the US CDC’s definition that the condition encapsulates many overlapping conditions, risk factors, and outcomes.

NEW! Managing Effective Fire Prevention Programs Student Recruitment

The National Fire Academy (NFA) has vacancies in the August 4-9, 2024 delivery of Managing Effective Fire Prevention Programs (R0671). R0671 will be held on the NETC Campus in Emmitsburg, Maryland.

Course Description:

This 6-day course is to empower students with the ability to lead a fire prevention/risk-reduction bureau. The course units will cover:

- Defining your new role.

- Fostering cultural change.
- Building fire prevention and risk-reduction bureau strength.
- Power, politics, and influence.
- Establishing bureau priorities and strategies.
- Organizational finances.

Student Selection Criteria: This course is designed for the student who has or will have responsibility for managing fire prevention/risk-reduction units. It is also designed for those who aspire to lead and/or manage sections of a fire prevention/risk-reduction bureau. The target audience is fire marshals, fire inspectors, fire and life safety educators, fire investigators and plan reviewers.

Prerequisites: ICS 100 level and ICS 200 level training. Preferred courses are Q0462 and Q0463, available through [NFA Online](#). Chief's signature attests that the applicant has completed this required training.

LEGISLATIVE ALERT | Summary of FY25 House Appropriations Bill | This week, the House Labor Health and Human Services and Education (LHHS) appropriations subcommittee released its version of the FY25 LHHS appropriation bill, detailing proposed funding levels across public health.

Some related highlights include:

- The bill *eliminates* funding for **Firearm Injury and Mortality Prevention Research**, a decrease of \$12.5 million below the FY24 enacted level.
- The bill *eliminates* funding for **Opioid Overdose Prevention and Surveillance**, a decrease of \$506 million below the FY24 enacted level.
- The bill *eliminates* funding for **Suicide Prevention**, a decrease of \$30 million below the FY24 enacted level.
- The bill *eliminates* funding for the **Climate and Health program**, a decrease of \$10 million below the FY24 enacted level.
- The bill *eliminates* funding for the **Center for Forecasting and Analytics**, a decrease of \$55 million below the FY24 enacted level.
- The bill includes \$564 million for **Global Health**, a decrease of \$129 million below the FY24 enacted level.
- The bill includes \$3.6 billion for **Administration for Strategic Preparedness and Response (ASPR)**, an increase of \$3 million above the FY24 enacted level.

The proposed funding levels in the bill may be altered as both chambers of Congress are anticipated to negotiate before the current fiscal year ends on September 30, 2024. [Learn more.](#)
